- In case of Donation option:

MINIMUM CONTRIBUTION :

Main applicant: USD 150,000

Main applicant and spouse: USD 175,000

Family up to four members: USD 195,000

Per additional dependant: USD 10,000

DUE DILIGENCE FEES

Main Applicant: USD 7,500

Spouse: USD 4,000

Dependant aged 16 years or above: USD 4,000

SUGAR INDUSTRY DIVERSIFICATION FOUNDATION (SIDF)

MINIMUM CONTRIBUTION :

Main applicant: USD 250,000

Main applicant and spouse: USD 300,000

Per additional dependant: USD 25,000

DUE DILIGENCE FEES

Main Applicant: USD 7,500

INVESTMENTS IN PRE-APPROVED REAL ESTATE

MINIMUM INVESTMENT :
